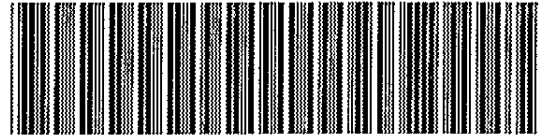

ARTICLE ONE

The name of the corporation is UNITED COMMUNITY EMPOWERMENT ASSOCIATION, INC.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

The purpose for which the corporation is organized is the transaction of any or all lawful business for which a corporation may be incorporated under Florida Corporation Act.

ARTICLE FOUR

The aggregate number of shares which the corporation shall have authority to issue is 1000 of the par value of one Dollar (\$1.00) each.

ARTICLE FIVE

The corporation will not commence business until it has received for the issuance of the shares consideration of the value of \$5,000.00 consisting of money, labor done or property actually received.

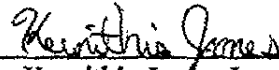

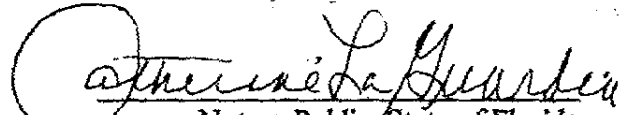

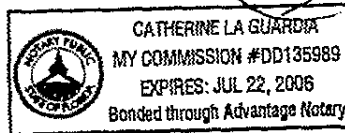
