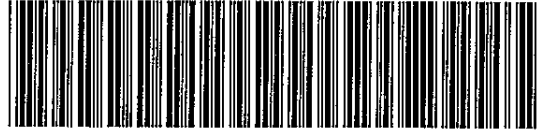

BY THESE ARTICLES OF INCORPORATION, the Incorporator forms a Corporation for Profit under Florida Law.

ARTICLE I - NAME

ARTICLE VII - INCORPORATOR

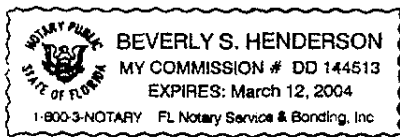
