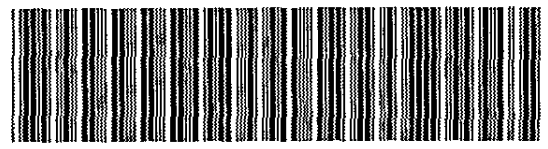



The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE I

The name of this corporation shall be: Naples Trim Works, Inc.

The duration of the corporation shall be perpetual.

ARTICLE III
