ARTICLES OF INCORPORTATION OF All Dade Supply, Inc.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida.

ARTICLE I-NAME

The name of the corporation is ALL DADE SUPPLY, Inc.

ARTICLE II-DURATION


