The purpose for which the corporation is formed and business or objects to be carried on and promoted by it are as follows:

To design, buy and sell, and import and export appliances, hardware, and durable goods of every make, and to buy and sell, import and export supplies, parts and accessories for automobiles, automobile trucks and tractors of every make.

In aid of, or in connection with, the foregoing, or in the use, management, improvement, or disposition of its property, and in addition to all other powers conferred by law, the Corporation shall have power:

- (a) To engage in any other manufacturing, mercantile, or merchandising business of any kind or character whatsoever, and to that end to acquire, own, hold and dispose of any and all property of any nature.
- (b) To purchase, lease, rent, hire or otherwise acquire, hold, own, develop, improve and in any other manner dispose of, and to improvement of, real and personal property, and rights and privileges therein, suitable or convenient for any of the business of the Corporation.
- (c) To purchase, lease, rent, hire or otherwise acquire, hold, own, construct, erect, improve, manage, operate and in any manner dispose of, and to aid and subscribe toward the acquisition, construction or improvement of plants, mills, factories, works, buildings, machinery, equipment and facilities, and any other property or appliances which may appertain to or be useful in the conduct of any of the business of the Corporation.
- (d) To apply for, obtain, purchase or otherwise acquire, any patents, copyrights, licenses, tradenames, trade-marks, rights, processes, formulas, and the like which may seem capable of being used for any of the purposes of the Corporation, and to use, exercise, develop, grant licenses in respect of, sell and otherwise turn to account, the same.
- (e) To engage in and carry on any other business which may conveniently be conducted in conjunction with any of the business of the Corporation.
- (f) To acquire the whole or any part of the good will, rights, property, and business of any person, firm, association or corporation heretofore or hereafter engaged in any business similar to any business which the Corporation has the power to conduct, and to hold, utilize, enjoy and in any manner dispose of the whole or any part of the rights, property and business so acquired, and to assume in connection therewith any liabilities of any such person, firm, association or corporation.

- (g) To acquire, by purchase, subscription, or in any other manner, take, receive, hold, use, employ, sell, assign, transfer, exchange, pledge, mortgage, lease, dispose of, and otherwise deal in and with, any shares of stock, shares, bonds, debentures, notes, mortgages or other obligations and any certifications, receipts, warrants, or instruments evidencing same, or representing any other rights or interests therein or in any property or assets, issues, or created by any persons, firms, subdivisions thereof, and to possess and exercise in respect thereof any and all rights, powers and privileges of individual holders.
- (h) To purchase or otherwise acquire and to hold, sell or otherwise dispose of, and to retire and reissue, shares of its own stock of any class in any manner now or hereafter authorized or permitted by law.
- (i) To borrow or raise money for any of the purposes of the Corporation, and to issue bonds, debentures, notes or other obligations of any nature, and in any manner permitted by law, for moneys so borrowed or in payment for property purchases, or for any other lawful consideration, and to secure the payment thereof and of the interest thereon by mortgage or pledge or conveyance of assignment in trust of the whole or any part of the property of the Corporation, real or personal, including contract rights, whether at the time owned or thereafter acquired, and to sell, pledge, discount or otherwise dispose of such bonds, debentures, notes or other obligations of the Corporation for its corporate purposes.
- (j) To aid in any manner any person, firm, association, corporation, or syndicate, and to hold any share of stock, share, bonds, debentures, notes, mortgages or other obligation or any certifications, receipts, warrants or other instruments evidencing rights, or options to receive, purchase or subscribe for the same, or representing any other rights or interests therein, which are held by or for this Corporation, or in the welfare of which this Corporation shall have any interest, and to do any acts or things designed to protect, preserve, improve and enhance the value of any such property of this Corporation.

(m) To carry out any part of the aforesaid objects and purposes, and to conduct its business in all or any of its branches, in any or all states, territories, districts and possessions of the United States of America and in foreign countries, and to maintain offices and agencies in any and all states, territories, districts and possessions of the United States of American and in foreign countries.

The foregoing objects and purposes shall, except when otherwise expressed, being no way limited or restricted by this or any other article of the Articles of Incorporation or of any amendment thereto, and shall each be regarded as independent, and construed as powers as well as objects and purposes.

The Corporation shall be authorized to exercise and enjoy all the powers, rights and privileges granted to, or conferred upon corporations of a similar character by the Code of Law for the State of Florida now or thereafter in force, and the enumeration of the foregoing powers shall not be deemed to exclude any powers, rights or privileges so granted or conferred.

Article IV: The total number of shares of the authorized capital stock of the Corporation is 1,000 shares of common stock or no par value.
