ARTICLE I. CORPORATE NAME

The person named as initial director shall hold office for the first year of existence of this Corporation or until their successors are elected or appointed and have qualified, whichever occurs first.

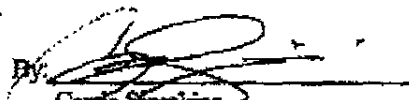
ARTICLE VII. INCORPORATOR
