ADMINISTRATION DISSOLUTION FOR ANNUAL REPORT/ PROFIT CORPORATION REINSTATEMENT


To Whom I May Concern:

Per a conversation with a state auditor on this date this corporation was dissolved on September 19, 2003. The 2003 Annual Uniform Business Registration was filed on April 4, 2003 and a check (#1322) for the \$150.00 annual fee cleared the bank on April 14, 2003.


