**ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME AND PRINCIPAL ADDRESS

The name of the corporation is Cooper Homes Group at Longleaf, Inc., and the principal address and principal place of business is 9020 Rancho Del Rio, Suite 102, New Port Richey, Florida 34654

ARTICLE II - REGISTERED OFFICE AND AGENT
