ARTICLE I - NAME AND ADDRESS

The name of this corporation is **TELEFONICA DATA MERGER COMPANY** (the "Corporation"). The address of the principal office and the mailing address of the Corporation is 1221 Brickell Avenue, Suite 600, Miami, Florida 33131.

ARTICLE II - PURPOSE

The Corporation is organized for the purpose of transacting any and all lawful business.

ARTICLE III - CAPITAL STOCK


