
ARTICLE IX - INDEMNIFICATION



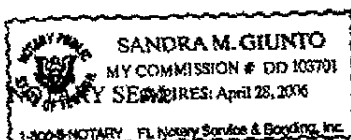
