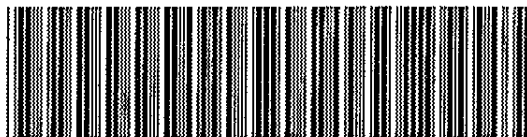

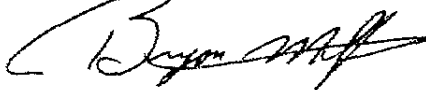

OF

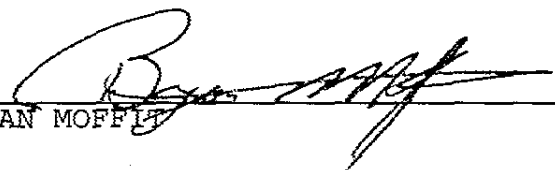

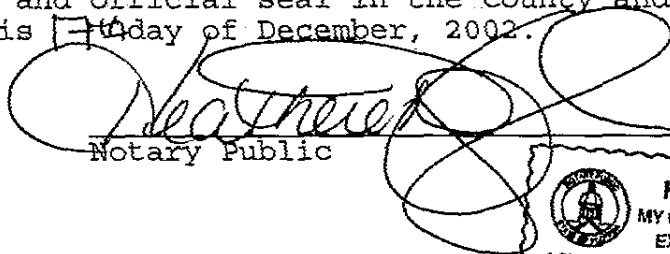
