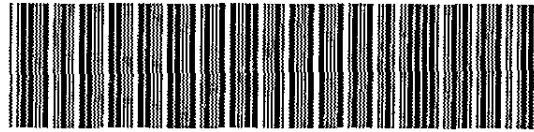

of

The undersigned Incorporator organizes a professional corporation under the Professional Services Corporation Act and the Florida General Corporation Act and adopts the following Article of Incorporation.

**Article I  
Name**

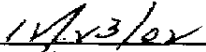

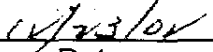
