## ARTICLES OF INCORPORATION OF MAUI ENTERPRISES, INC.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following articles of incorporation:

## ARTICLE I

The name of the Corporation is MAUI ENTERPRISES, INC.
