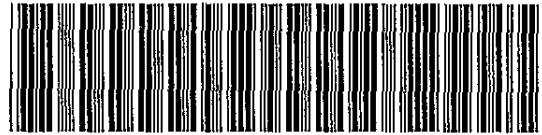

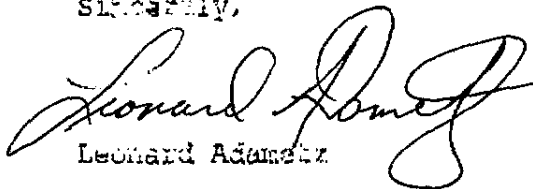

ARTICLE XII - SUB-CHAPTER S CORPORATION

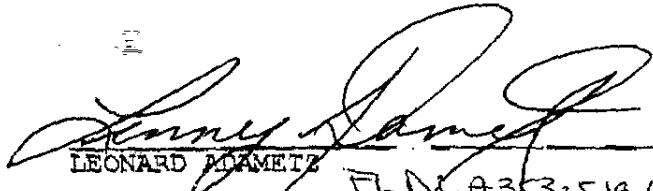

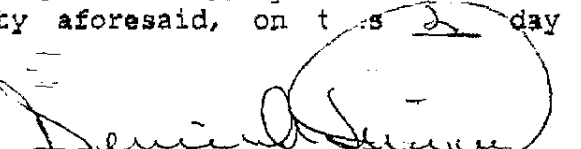

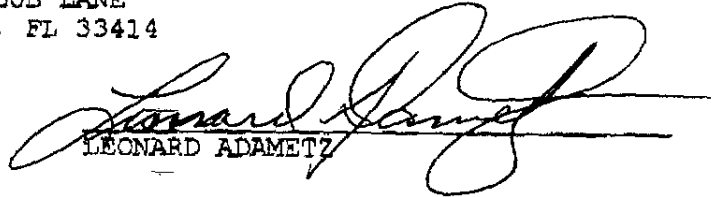
