Articles of Incorporation Of S.W.S. Carpentry, Inc.

The undersigned incorporation, for the purpose of forming a corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

Article 1. Name. The name of the Corporation shall be: S.W.S. Carpentry, Inc.

Article 2. Address. The mailing address and principal office of the Corporation is 9608 Six Mile Creek Road, Tampa, Florida 33610.

Article 3. Anthorized Shares. The Corporation is authorized to issue one class of shares, which shall be called common shares. The price, terms and other provisions regarding this restriction may be specified by written agreement among the Shareholders, which agreement may expand this Article and which may also include the Corporation as a party. These restrictions are intended to preserve exemptions under federal and state securities laws, to provide for orderly changes in ownership of shares, and to serve other reasonable purposes.

Article 12. Rights of Initial Directors. Each of the initial Directors shall have the right to be a Director of the Corporation as long as that respective Director is a Sharcholder of the Corporation. By acquiring shares in this Corporation, each Shareholder agrees to abide by this right and to elect each of the initial Directors named in these Articles of Incorporation to the office of Director as long as that Director is a Shareholder of the Corporation.
