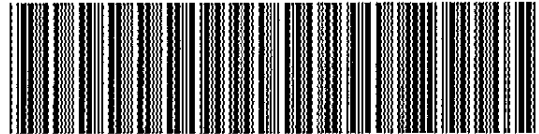

SHARES

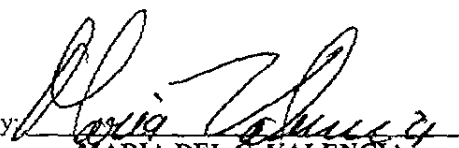
