The undersigned, acting as Incorporators, adopt and file these Articles of Incorporation and form a general insurance and reinsurance company for the purpose of insurance, other than life insurance (the "Corporation") under the Florida Business Corporation Act (the "Act"), as follows:

I. <u>Name</u>

The name of the Corporation is Crum National Insurance, Inc. Its principal office is located in Pinellas County, Florida at 3040 Gulf to Bay Boulevard, Suite 110, Clearwater, Florida 33759.

II. Term of Existence

The Corporation's existence commences on the date of the filing of these Articles of Incorporation with the Department of State of the State of Florida. The Corporation will have perpetual existence thereafter unless dissolved according to law.

III. Purposes

The purposes for which the Corporation is formed are as follows: (a) to transact a general insurance and reinsurance business, other than life insurance, in any of the kinds of insurance authorized by the Florida Insurance Code, Chapters 624, et seq. of the Florida Statutes, as it may be amended from time to time; (b) to perform all acts now or hereafter permitted to be done by a domestic stock insurance company under Florida law; and (c) to conduct any other lawful business permitted under the Act.

IV. Capital Stock

The Corporation is authorized to issue 7,500 shares of \$1.00 par value common stock, which will be designated Common Stock.

The Common Stock will be issued for such consideration as may be determined by the Board of Directors.

The Corporation will have 7 directors initially. The term of office of the initial directors shall be for one year after the date of incorporation. The number of directors may be increased or decreased from time to time as provided in the bylaws of the Corporation, but the Corporation will always have at least 5 directors. The Corporation elects not to be governed by the requirements or other provisions regarding control-share acquisitions of Section 607.0902 of the Act. Therefore, the terms and provisions of Section 607.0902 will not apply with respect to any control-share acquisition of any equity securities of the Corporation and the equity securities of the Corporation will have any and all other rights and privileges available under the Act.
