#### ARTICLE I - NAME

The name of this corporation is Dance University, Inc. The address for the corporation is 2022 Nolan Drive, Dunedin, Florida 34698.

#### ARTICLE II - DURATION

This corporation shall exist for a perpetual period.

## ARTICLE III - PURPOSE
