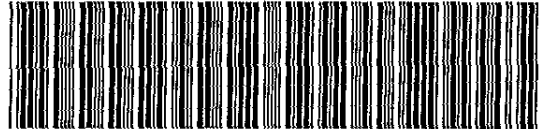

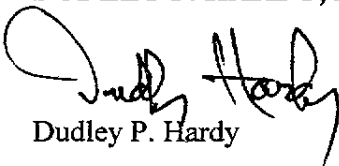

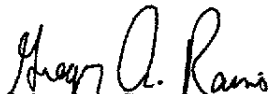
Article VIII- Effective Date
