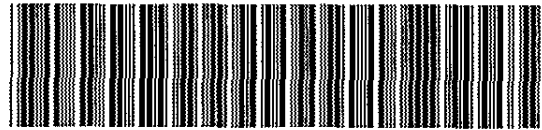

ARTICLES OF INCORPORATION

OF

MEDICAL SOLUTIONS STAFFING, INC.

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be Medical Solutions Staffing, Inc. The principal place of business of this corporation shall be 2545 NE Coachman Road, Suite 190, Clearwater, FL 33765.

ARTICLE II. NATURE OF BUSINESS

This corporation may engage or transact in any or all lawful activities or businesses permitted under the laws of the United States, the State of Florida or any other state, county, territory or nation.

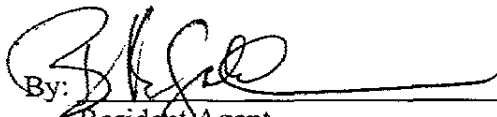
