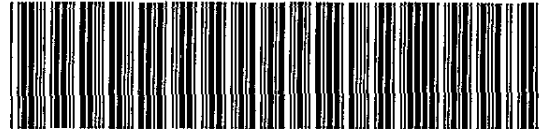

OF
