ARTICLES OF INCORPORATION OF

KONDROSKI DRAFTING & DESIGN, INC.

The undersigned incorporators of these Articles of **PowerJamms, Inc.**, each a natural person competent to contract, associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I

NAME: The name of this corporation Kondroski Drafting & Design Anc

ARTICLE II

CORPORATE PURPOSES: The corporate purposes are:

To engage in any lawful act or activity for which corporations may be organized under the laws of the State of Florida. To market, sell, and provide drafting, designing and design drawing services, and to own and/or operate equipment, data bases, lists and other assets necessary in carrying on the business of providing such services and related products.
