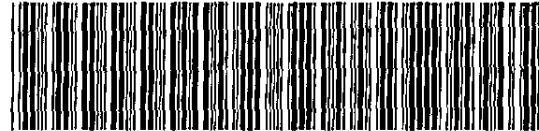

Article I

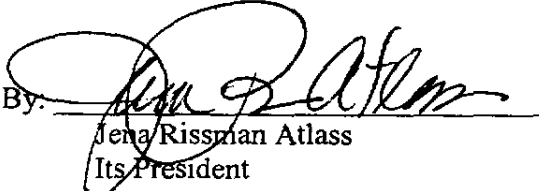
Corporation Name
