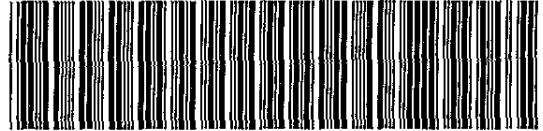

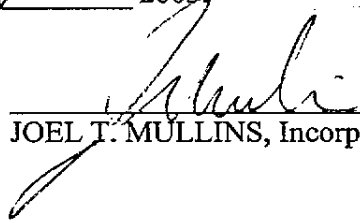
The undersigned incorporator for the purposes of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation:

- FIRST:** The name of the corporation is JOEL T. MULLINS, P.A., a Florida Corporation (the "Corporation").

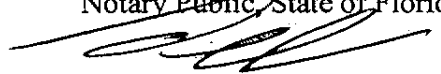

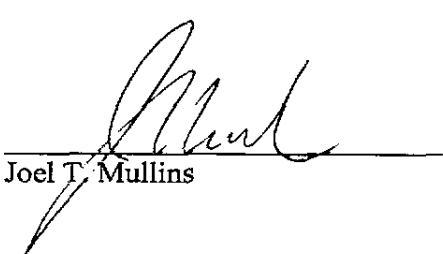
