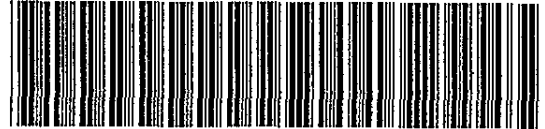

TO

1. The name of the corporation is Highlands Occupational and Environmental Medicine, P.A.


2. Article I of the Articles of Incorporation of Highlands Occupational and Environmental Medicine, P.A. was amended as follows:
