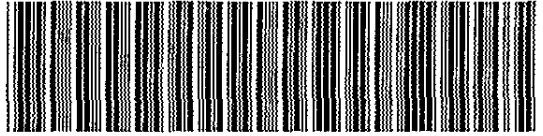


ARTICLE VIII


