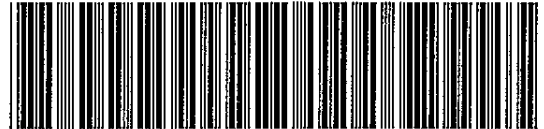

I, the undersigned, bring myself for the purpose of becoming a corporation under the laws of the State of Florida, providing for the formation of a corporation for profit, with the powers, rights, privileges, and immunities hereinafter mentioned, and I make, subscribe, acknowledge and file with the Department of State of Florida this Certificate of Incorporation and to that end I do by this Certificate set forth:

ARTICLE I.

The name of the Corporation is Tropical Flooring and Interiors, Inc.

ARTICLE II.

The principal place of business is 840 Jupiter Park Dr. Suite 105 Jupiter, Florida 33458. The mailing address is the same.

ARTICLE III.

The general nature of the business, objects and purposes to be transacted and carried on are to do all and any things allowed and permitted to be done by corporations under the Statues of the State of Florida and to the same extent as natural persons might or could, to - wit:

A) To enter into contracts providing construction labor , materials, and services to private owners, businesses, and the public in general:
