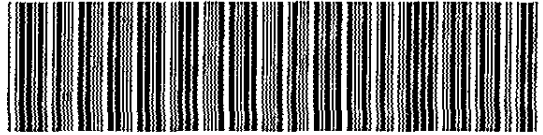

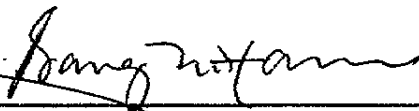

ARTICLE I

NAME OF CORPORATION

The name of the Corporation is YSK Janitorial Services, Inc.

ARTICLE II
