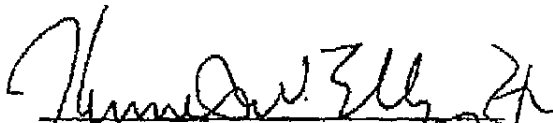
Article I. Name. The name of the Corporation shall be:

2. The foregoing Amendment was adopted by all the Stockholders and Directors of the corporation on the 28th day of March 2003.

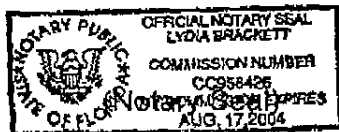
