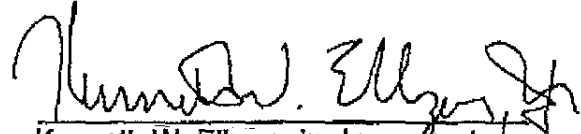

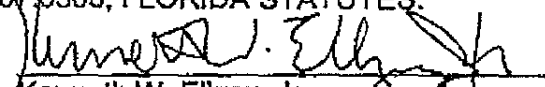
**Article VI. Term of Existence.** The Corporation shall have perpetual existence.
