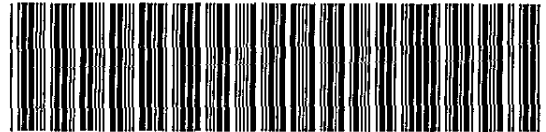

**Name**


