STATE OF FLORIDA AMENDED AND RESTATED ARTICLES OF INCORPORATION OF BROUN AND COMPANY, INC.

Pursuant to Sections 607.1006 and 607.1007, Florida Statutes, this Florida corporation, desiring to amend and restate its Articles of Incorporation in their entirety which were filed on March 18, 2003, under the name of Broun and Company, Inc. does certify as follows:

"Article 1. Name. The name of the Corporation is:
