ARTICLES OF INCORPORATION

FLORIDA CRAKER CONSULTANT & PERMIT SERVICES, INC.

ARTICLE I - NAME

The name of this corporation is: FLORIDA CRACKER CONSULTANT & PERMIT SERVICES, INC.

ARTICLE II - DURATION

This corporation is to exist perpetually. It shall commence its existence at the time of filing these Articles of Incorporation.
