ARTICLES OF INCORPORATION OF RONALD E. SHOLES, P.A.



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation shall be Ronald E. Sholes, P.A.

<u>ARTICLE II – NATURE OF BUSINESS</u>

This corporation may engage in the practice of law and all lawful activities or business pertaining thereto which is permitted under the laws of the United States, the State of Florida, or any other state, county, territory, or nation.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any one time is 2000 shares of common stock having a par value of \$1 per share.

<u>ARTICLE IV – ADDRESS</u>

The street address of the initial registered office of the corporation shall be 486 N. Temple Avenue, Starke, Florida 32091, and the name of the initial Registered Agent for the corporation at that address is Ronald E. Sholes.

Any director of corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.
