**CERTIFICATE OF INCORPORATION

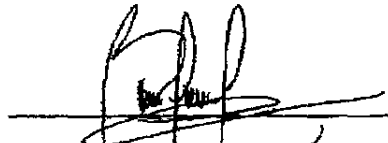

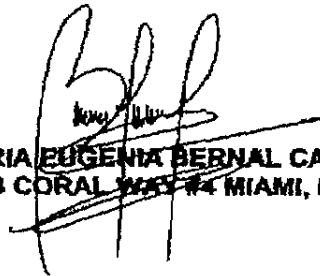
