**ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF**

IDEAL IMAGE DEVELOPMENT CORPORATION

Pursuant to the provisions of Section 607.1006 of the Florida Business Corporation Act, this Corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: The name of the corporation is:

IDEAL IMAGE DEVELOPMENT CORPORATION

SECOND: Article V of the Corporation's Articles of Incorporation is amended in its entirety as follows:

"ARTICLE V - CAPITAL STOCK

The Corporation is authorized to issue One Hundred Thousand (100,000) shares of One Cent (\$.01) par value common stock, which shall be designated "Common Stock", as follows:

1. Ten Thousand (10,000) shares of voting common stock, which shall be designated "Voting Common Stock"; and
2. Ninety Thousand (90,000) shares of nonvoting common stock, which shall be designated "Nonvoting Common Stock".

Other than the difference in voting rights described above, all shares of Common Stock shall have the same rights and preferences."

THIRD: Article XI of the Corporation's Articles of Incorporation is amended in its entirety as follows:

"ARTICLE XI - SHAREHOLDER ACTION

Except as otherwise required by the Florida Business Corporation Act, an affirmative vote of greater than fifty percent (50%) of the shares of Voting Common Stock of the Corporation shall be required for any Shareholder action"

FOURTH: The date of adoption for the above amendments is December 10, 2004.

FIFTH: The above amendments were approved by all of the shareholders and by all of the members of the Board of Directors. The number of votes cast for the amendments were sufficient for approval.

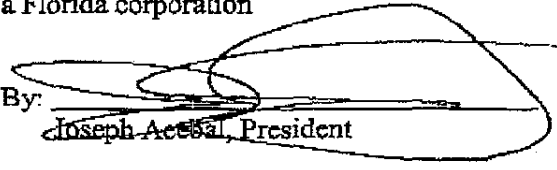
