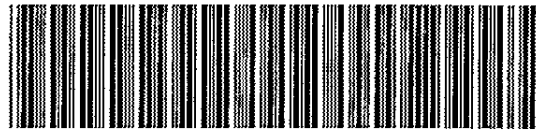

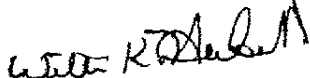

ARTICLE X. BYLAWS

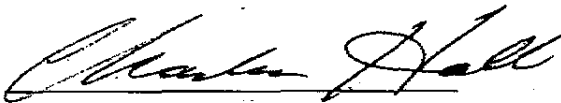

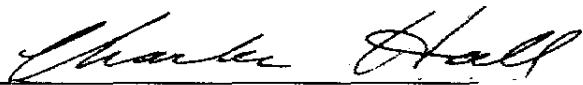
