

ARTICLES OF INCORPORATION

OF

MARITIME CONSULTANTS & MARINE SERVICES INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopt the following articles of incorporation:

ARTICLE 1

The name of this corporation shall be: Maritime Consultants & Marine Service

ARTICLE II

The duration of the corporation shall be perpetual.

ARTICLE III


