## Articles of Incorporation of Gary S. Wright, P.A.

The undersigned natural person, competent and licensed to practice aw income the State of Florida, desiring to form a professional corporation in accordance with Chapter 607 of the Florida Statutes and the Florida Professional Service Corporation Act, does hereby adopt the following Articles of Incorporations:

Article I - Name The name of the Corporation shall be Gary S. Wright, P.A.

#### Article II - Purpose

The purpose for which the Corporation is organized shall be to engage in and carry on all branches of the practice of law within the State of Florida, and to do those things that are necessary or proper in connection with that practice, including, but not limited to, the following:

- A. To engage in every aspect in the practice of law and all its fields of specializations, as are engaged in by attorneys.
- B. To engage and render the professional services involved only through its officers, agents and employees who shall be in good standing and duly licensed or otherwise legally authorized within the State of Florida to render the same professional service as this Corporation.
- C. To purchase, lease, or otherwise acquire, to own, hold, and operate, and to sell, mortgage, pledge, lease, employ, or otherwise dispose of, encumber, or invest in such real estate, mortgages, stocks, bonds, and all types of personal property, tangible or intangible, as may be reasonably required in the conduct of its professional business and in connection with any other proper business activity in which the Corporation may engage.
- D. To enter into and make all necessary contracts for the conduct of its professional business with any person, partnership, association, corporation, or other entity, and to perform, carry out, cancel, and rescind those contracts.
- E. To borrow or raise money reasonably required in the conduct of its professional business and in connection with any proper business activity in which the Corporation may be engaged; and to execute and deliver any instruments that may be necessary to evidence the borrowing.
- F. To engage in no other business other than the rendition of the professional services specified herein.

G. To do everything necessary, proper, advisable, or convenient for the accomplishment of the corporation purposes herein set forth and to do anything incidental thereto which is not forbidden under the laws of the State of Florida.

#### Article III - Duration

The Corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

#### Article IV - Capital

The amount of stated capital with which th Corporation shall begin business is One Thousand and no/100 Dollars (\$1,000.00).

#### Article V - Capital Stock

- A. The maximum number of shares that the Corporation is authorized to have outstanding is 100 shares. All shares shall be common shares with a par value of Ten Dollars (\$10.00).
- B. No share of stock of this Corporation shall be issued or transferred to any person who is not an attorney, duly licensed to practice law in the State of Florida.

#### Article VI - Registered Agent

The address of the initial registered office of the Corporation in this State is 295 Adelaide Street, DeBary, FL 32713. The initial registered agent at the registered office is Gary S. Wright.

#### Article VII - Incorporation

The name and address of the incorporator is: Gary S. Wright, 295 Adelaide Street, DeBary, FL 32713.

#### Article VIII - Management

The business of the Corporation shall be managed by the Shareholders of the Corporation rather than by a Board of Directors.

#### Article IX - Informal Shareholder Action

Any action of the Shareholders may be taken without a meeting if consent in writing setting forth the action so taken shall be signed by all the Shareholders entitle to vote upon such action at a meeting and filed with the Secretary of the Corporation as part of the corporate records.
