

OF

**ARTICLE I
NAME**

The name of this corporation is ESTEVEZ PAINTING COMPANY, INC.

**ARTICLE II
DURATION**

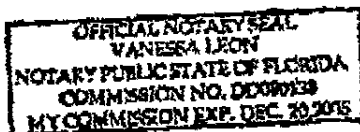
