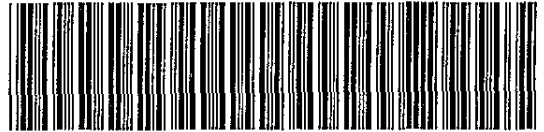

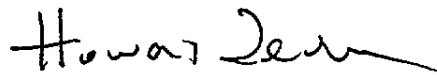

FOR BUSINESS PARTNERS OF THE WEST, INC.**

The undersigned, for the purpose of forming a Florida corporation pursuant to Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation.

**ARTICLE I. NAME**

The name of the corporation shall be: **BUSINESS PARTNERS OF THE WEST, INC.**

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:  
300 South Pointe Drive, Suite 3704, Miami Beach, Florida 33139.

**ARTICLE III. CAPITAL STOCK**

The number of shares of stock that this corporation is authorized to have outstanding at one time is 1,000,000 shares of common stock, with no par value.

Authorized capital stock may be paid for in cash, services, or property, at a just value to be fixed by the Board of Directors of this corporation at any regular or special meeting. The initial capital contribution by the Nicholas Papadopoulos, as the Incorporator and sole shareholder shall be Three Thousand and No/100 Dollars (\$3,000.00).

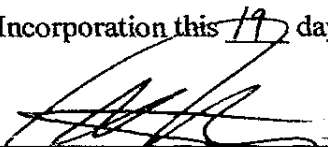
**ARTICLE X. EFFECTIVE DATE**

**ARTICLE XI. AMENDMENT**

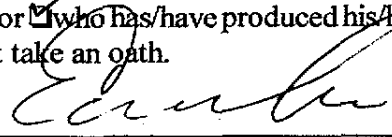

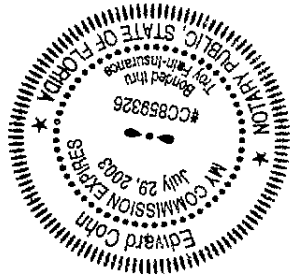
