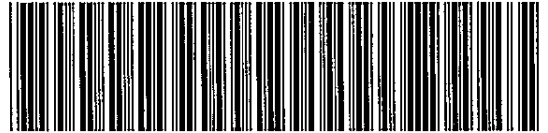


ARTICLE VIII - INDEMNIFICATION



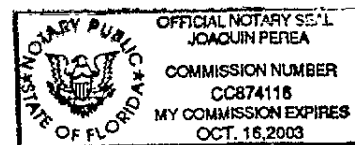
