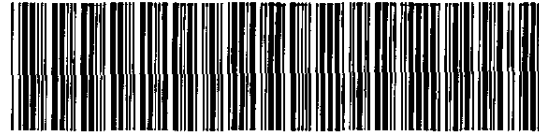

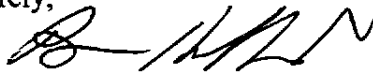
Dear Sir or Madam:

Article I is hereby deleted in its entirety and replaced with the following:

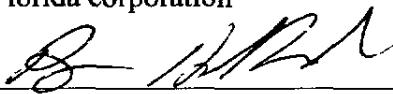
ARTICLE I
