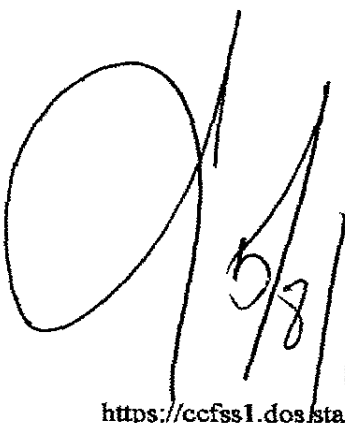

FIRST. The name of the corporation is C&B #1Enterprises Inc.

SECOND. The street address of the initial principal office of the corporation is 28131 Lake Jam Rd., Mt. Dora, Florida 32757.

THIRD. 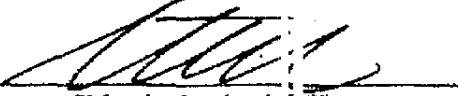

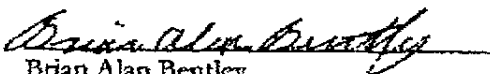
