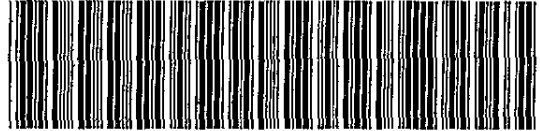

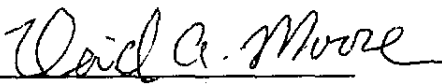

ARTICLE ONE

The name of the corporation is **TROPIC SKY CONSULTING, INC.** The principal address of the corporation is: 3220 BAYVIEW DRIVE, # 201, FT. LAUDERDALE, FL. 33306.

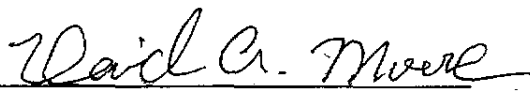
ARTICLE EIGHT
