The undersigned subscribers hereby associate themselves together to form a corporation for profit under the laws of the STATE OF FLORDIA: and hereby adopt the following ARTICLES OF INCORPORATION.

ARTICLE I NAME

The name of this Corporation shall be: RODRIGO OJEDA, P.A. and it's business shall be carried on in BROWARD COUNTY, FLORIDA, and also within and without the STATE OF FLORDIA, and UNITED STATES OF AMERCIA and FOREIGN COUNTRIES as may from time to time be deemed desirable or expedient.
