# ARTICLES OF INCORPORATION OF JR JASZ. INC.

The undersigned, for the purpose of forming a corporation for profit under the laws of Florida, adopts the following Articles of Incorporation:

#### Article I Name

Section 1.1. Name. The name of this corporation shall be JR JASZ, INC.

### Article II Principal Office and Mailing Address

<u>Section 2.1. Principal Office and Mailing Address.</u> The principal place of business and malling address of this corporation shall be 96080 Bay View Drive, Fernandina Beach, Florida 32034.

# Article III Capital Stock

- <u>Section 3.1</u>. <u>Capital Stock</u>. The maximum number of shares of stock which this corporation is authorized to have outstanding at any one time is 7,500 shares of voting common stock and 22,500 shares of nonvoting common stock, each having a par value of \$0.10 per share.

The approval of the shareholders holding sixty percent (60%) or more of the capital stock of this corporation eligible to vote to any plan of merger or consolidation shall be required in every case, whether or not such approval is required by law.
