The undersigned, acting as incorporator of a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such Corporation:

ARTICLE I - NAME

The name of this Corporation is THE LAW OFFICES OF MARK A. SIERON, P.A.

ARTICLE II - PRINCIPAL OFFICE

The principal office and mailing address of this corporation shall be: 1045 N. Orange Avenue, Green Cove Springs, Florida 32043.

ARTICLE III - DURATION

This corporation shall commence business upon filing with the Secretary of State, and thereafter shall exist perpetually.

ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000.00 shares of \$1.00 par value common stock.

- (c) The transaction of any and all other lawful business for which corporations may be incorporated and the doing of all

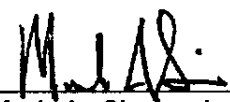
ARTICLE IX- RESTRAINT ON TRANSFER OF SHARES

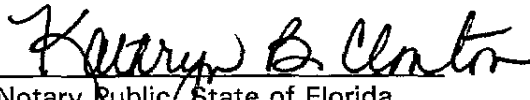
