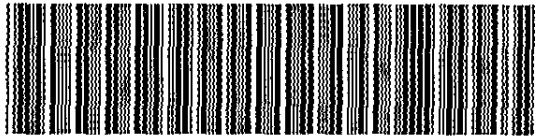

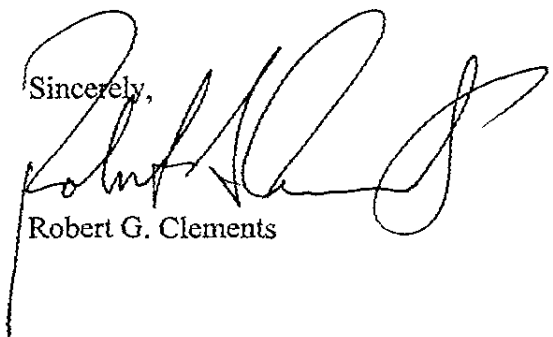

**ARTICLES OF INCORPORATION  
OF  
LEWIS MOSTOW, P.A.  
a Professional Corporation**

In compliance with the requirements of F.S. Chapter 607, and F.S. Chapter 621, the undersigned, being a natural person, hereby acts as incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I - NAME**

The name of the Corporation ("Corporation") is Lewis Mostow, P.A.

**ARTICLE II - ADDRESS**

The street address of the initial principal office of the Corporation is:

**ARTICLE III - DURATION**

The existence of the Corporation shall begin on the date these Articles of Incorporation are filed and shall be perpetual.

**ARTICLE IV - PURPOSE**
