**ARTICLES OF INCORPORATION
OF
AMERICAN FREIGHT BROKERS, INC.**

The undersigned Incorporator subscribing to these Articles of Incorporation, being competent to contract, hereby forms a Corporation under the Laws of the State of Florida.

ARTICLE I

The name of this Corporation shall be: AMERICAN FREIGHT BROKERS, INC., and its initial mailing address shall be: P.O. Box 14247, Bradenton, Florida 34280-4247. The initial address of the Corporation's principal office shall be: 4301 32nd Street West, Bradenton, Florida 34205.

ARTICLE II

The purpose of this Corporation is to engage in any and all business not prohibited by the Laws of the State of Florida.

This Corporation shall have all powers given corporations under the Laws of the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to have outstanding at any one time shall be five hundred (500) shares of common stock having a par value of One Dollar (\$1.00).

ARTICLE IV

This Corporation is to exist perpetually.

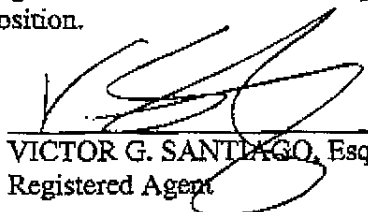
